Regular Session – November 9, 2020

<u>CALL TO ORDER</u>: The Perry Central Community School Corporation Board of School Trustees met in a Regular Session on November 9, 2020. The meeting began at 6:31 PM, with the Pledge of Allegiance in the Jr-Sr High School Library. Board members Joe Flamion, Kevin Etienne, Nan DuPont, and Glenn Etienne were present along with Tara Bishop, Superintendent; Jody French, Principal; Jennifer Mitchell, Principal; Jamie Guillaume, Assistant Principal; Phil Zellers, Assistant Principal; Levi Clark, SRO; Kristi Etienne; and Eric Whittaker representing the *Perry County News*.

CONSENT: On a motion by Kevin Etienne, seconded by Joe Flamion, and carried 4-0, the following consent items were approved.

<u>PERSONNEL</u>: Nan DuPont made the motion that was seconded by Joe Flamion to approve the following personnel items. The motion carried 4-0.

- Approve Brandy Cummings to transport student in foster care to/from school at rate of \$10 per one-way trip (in school vehicle)
- Adjust Brittney Carter's time to an 8-hour day, retroactive to the start of the 2020-2021 school year
- Approve stipend for Professional Development "Leaders of Learning" for \$50 per training session (Paid through Title II Grant)

(Note: All new employees are hired on a temporary basis and will not be considered fully employed until an Expanded Criminal History Check is completed.)

CONTRACT RATIFICATION: After providing an opportunity for public comment as required by law, (No public comments were presented.) Kevin Etienne made the motion to ratify the 2020-2021 contract with the Perry Central CTA. The motion was seconded by Nan DuPont and carried 4-0.

<u>PARENT TRANSPORTATION CONTRACT</u>: Joe Flamion made the motion that was seconded by Nan DuPont and carried 4-0 to approve the parent transportation contract with Alice Bauer.

2021-2022 SCHOOL CALENDAR: On a motion by Joe Flamion, seconded by Nan DuPont, and carried 4-0, the 2021-2022 school calendar was approved.

BUILDING ADMINISTRATOR CONTRACT ROLLOVERS: Nan DuPont made the motion to

BUDGET REPORTS: Monthly Appropriation, Revenue, Expenditure and Fund reports were distributed and board members were given an opportunity to review and question.

SUPERINTENDENT COMMENTS: Superintendent Bishop congratulated fall sports and band for a great season. She also shared that we hope to be able to return to in-person classes next Monday, November 16th. Dr. Bishop thanked the Classroom Teachers Association for a successful bargaining season and commented that we are grateful for the positive working relationship we have with the CTA.

BOARD MEMBER COMMENTS: Glenn Etienne and Kevin Etienne thanked the teachers and board members on the negotiation committee for always working so well together. Nan DuPont commented on a great season that all the fall sports were able to have, it was a tough loss for the football team Friday night, but they had a great season.
